Certification

- Those taking the course are eligible to take the Playground Safety Inspectors Exam given immediately after the course. Upon passing the exam, you will be certified through the National Recreation and Park Association as a Certified Playground Safety Inspector (CPSI) for a 3 year period. Certificates will be awarded and your name will be added to a national roster of CPSI's.

- Option 1 Course and Exam You can take both the course and exam like you did three years ago. See Registration form.
 - Option 2 Exam only Register with the FRPA and pay for the exam fee, \$100. We will then send you information on the location of the exam. You must have taken the course previously to take just the exam.
