USER TRAINING

Released in August, the **FRPA Impact Calculator** is a powerful tool to capture and display the impact of parks and recreation activities.

Developed by a panel of national experts and grounded in evidence-based research, the Impact Calculator allows a park agency to enter a few data points of information and create a report of those findings. This training will orient participants on how to utilize the tool, and more importantly how to use the results to share the story of your impact to your community. Attend this training and be equipped to understand impact and be prepared to share that impact with audiences within your community.

- Participants are encouraged to bring a laptop for maximum interaction.
- Agencies are encouraged to register multiple people who may work together on identifying and collecting data.
- Participants will be sent a list of items to bring with them to the training prior to the date.

This workshop is for FRPA Members only. Current Membership with FRPA is required to enter the Calculator. Training will award .4 CEUs.
