



# Certified Playground Safety Inspector

## VIRTUAL COURSE

The Florida Recreation and Park Association on behalf of the National Recreation and Park Association is offering the Certified Playground Safety Inspector (CPSI) course and certification to properly train and certify individuals to recognize and prevent potential playground hazards. Courses are designed for park and recreation staff, school districts, child care facilities, health departments, landscape architects, playground manufactures, installers, contractors, insurance firms, home owner's associations, and more.

**Registration Deadline: June 28, 2024**

All log in and deadline details will be sent once payment for registration is received. Virtual information will be sent by email. Please be sure your email is clearly written or typed and everyone **MUST** have their own email address.

Those taking the course are eligible to take the Playground Safety Inspectors Exam given following the virtual course. Upon passing the exam, you will be certified through the National Recreation and Park Association as a Certified Playground Safety Inspector (CPSI) for a 3 year period. Certificates will be awarded and your name will be added to a national roster of CPSIs.

**Cancellation/Substitution/Accommodations Policies**

- Cancellations must be submitted in writing and received by **June 28, 2024** in order to receive a refund of the registration fee less \$250 for manuals plus a \$125 service charge.
