SESSIONS

Restoring Florida's Coral Reef: *From Banking to Breeding and everything in Between* (CEUs: 0.1)

An overview of Mote's science-based coral reef restoration framework and how its scientists are developing and implementing novel interventions for safeguarding the future of Florida's Coral Reef

Learning Objectives:

- ◇ Discuss coral reproduction and propagation.
- ◇ Learn about implementing novel intervention techniques.
- ◇ Explore coral reef research and restoration.

Dr. Hanna R. Koch, Scientist with Mote Marine | Dr. Koch is a coral reproduction scientist and established the Coral Reproduction Research Program at Mote Marine Laboratory's Elizabeth Moore International Center for Coral Reef Research & Restoration on Summerland Key. Her team breeds coral in the lab for creating more stress-tolerant offspring that will be used for active restoration in Florida, for adding fresh genetics to Mote's asexual coral propagation pipelines, and for carrying out assisted sexual reproduction research to more efficiently and effectively produce large numbers of genetically diverse offspring of various species.

Florida Keys National Weather Service Forecast Office Tour (CEUs: 0.1)

The session consists of a visit to the Florida Keys Office of the National Weather Service, one of 122 weather forecast operational field offices of the National Oceanic and Atmospheric Administration. Attendees will learn of the history of national weather warning and forecast services in the Florida Keys in the office multi-media and reception lobby, the operations floor where forecasts and warnings are prepared and disseminated, and the upper-air observation program's weather balloon launch facility.

Learning Objectives:

- ◇ Learn about the mission and operational forecast and warning objectives of a National Weather Service field office.
- ◇ Introduction to weather observation tools and their importance in National Weather Service operations.
- ◇ Meet the core partners the Florida Keys National Weather

Service Office that help the NWS in its mission to protect life and property in the Florida Keys and its adjacent coastal waters.

Jonathan Rizzo, Warning Coordination Meteorologist |

Jon Rizzo has served as the Warning Coordination Meteorologist (WCM), leading the weather decision support and preparedness programs for the National Weather Service Forecast Office in the Florida Keys since 2002. As WCM, Jon is the primary deployment-ready meteorologist serving Monroe County Emergency Management during tropical storm and hurricane events. Jon's 24-year running NWS career began at the Key West office in 1999, before a promotion to general forecaster for the NWS office in Spokane, Washington in early 2001. Jon is originally from Southern Maryland, and earned a Bachelors of Science Degree in Meteorology from Florida State University in 1995.

Cathy Crane serves all Veterans and Military Service Members and their dependents and survivors as the Director of Monroe County Veterans Affairs. Cathy moved to the Keys 20 years ago with her husband and daughter. Previously, she served as the Director of Operations and Finance for the Monroe County Tax Collector and was Chief Deputy Clerk for the Monroe County Clerk. She has a bachelor's in business administration and a master's in forensic accounting. Cathy's military career includes serving a hardship tour in Korea and serving as the NCOIC of a Medical Section for an Enemy Prisoner of War Camp in Iraq. Her 11 years of US Army military service include, among other Awards and Medals, the Army Com-

mendation Medal with "V" Device for Valor with 1 Oak Leaf Cluster. In 2023, Cathy was recognized as a Woman of Integrity for Military and Veterans Advocacy. As an active community member, she is the NACVSO Florida Legislative Delegate, Wounded Warrior Project Soldier Ride Committee Chair, and Florida CVSO Member & Past South Area Vice President.

Emergency Management in the Keys (CEUs: 0.1)

The Deputy Director of Emergency Management in Monroe County will provide an overview of Emergency Management in the Florida Keys. The presentation will cover the four phases of emergency management and the organizational structure, evacuation requirements, shelter information, and residential re-entry requirements before and after a declared disaster in the county. Additionally, we will explore how Florida Recreation and Parks can assist in the response and recovery efforts after a natural disaster impacts Monroe County.

Cory Schwisow, Deputy Director Monroe Co Emergency | Cory Schwisow is a retired United States Navy veteran with over 23 years of experience in leadership, management, and emergency response. Currently, he serves as the Deputy Director of Emergency Management for Monroe County, where he leverages his expertise to ensure the safety and well-being of the County. Cory's experience in emergency response is extensive, having served as the Emergency Manager for NAS Key West, FL during Hurricane Irma in 2017. His ability to make quick decisions under pressure and lead teams through complex situations was critical to the success of many operations. Throughout his career, Cory has been recognized for his outstanding leadership skills, having been awarded two Commander, US Naval Air Forces Leadership Awards, and multiple personal and command awards. He is a proud graduate of American Military University, where he earned a bachelor's degree in Applied Science, with a con-

centration in Project Management.
